

**A RESOLUTION
ADOPTING THE CALENDAR YEAR 2027 MEMBERSHIP FEE SCHEDULE**

WHEREAS, Toledo Metropolitan Area Council of Governments (now known as Lake Erie West Regional Council) is a voluntary association of local governments in northwest Ohio and southeast Michigan, organized on May 31, 1968, and established under Chapter 167 of the Ohio Revised Code and the Michigan Public Act No. 7 (EX-SESS), and has carried out comprehensive metropolitan and regional planning since that date; and

WHEREAS, the Lake Erie West Bylaws requires the Governing Board to annually adopt a membership fee schedule; and

WHEREAS, the last Calendar Year 2026 Membership Fee Schedule was adopted by the Governing Board on May 9, 2025, by Resolution No. 2025-13; and

WHEREAS, on March 13, 2026, the Governing Board approved the creation of a Dues Review Ad Hoc Committee consisting of Governing Board members to review and evaluate Lake Erie West's dues structure/mechanism and to make a recommendation to the Governing Board; and

WHEREAS, the Dues Review Ad Hoc Committee met on July 1, July 15, and August 7, 2026, and reviewed the current Calculation of Membership Dues Schedule, a historical analysis of dues, and an analysis of Lake Erie West's peer organizations; and

WHEREAS, during their review, the Dues Review Ad Hoc Committee received input from a working group consisting of General Assembly representatives from amongst member special districts and authorities; and

WHEREAS, the Dues Review Ad Hoc Committee reviewed and recommended the adoption of the *Member Dues Schedule Calendar Year 2027 Rates* on August 7, 2026; and

WHEREAS, the Finance, Audit, and Administration Committee reviewed and recommended the adoption of the *Member Dues Schedule Calendar Year 2027 Rates* on August 19, 2026.

NOW, THEREFORE, BE IT RESOLVED by the Lake Erie West Regional Council Governing Board that

Section 1: The *Member Dues Schedule Calendar Year 2027 Rates* attached hereto as Exhibit A is hereby approved and adopted for the Calendar Year 2027, beginning January 1, 2027, and ending December 1, 2027.

Section 2: That this resolution satisfies the Lake Erie West Regional Council's Bylaws.

Section 3: This resolution shall take effect immediately upon adoption with the approved rates to be applied to all invoices issued for the Lake Erie West Regional Council calendar 2027 membership year.
