

# TMACOG Public Water Supply Committee Meeting Minutes December 7, 2023 - 1:00 p.m. TMACOG Boardroom

# Welcome:

Andy McClure, Vice Chair, City of Toledo, began the meeting with welcome. He asked everyone to introduce themselves. He stated that as quorum had not been established, the agenda would be reordered.

## **Regional Water Commission Update:**

Andy McClure stated that the City of Toledo is working on its CIP update, AMI discussion and cash funded CIP. They have a minimum 100-year cycle for replacement instead of the current 400-to-500-year plan. The present H2O website will become the website for Regional Water updates. A subcommittee has been looking at cost of service elevation - new water rates sent to city council. Community Updates – Last phase of equalizing rates, the last 2 years of the rate increase reduced from 6% to 4%.

# Discuss 2024 Water Quality Committee Restructure and Annual Work Program:

Sara Guiher presented the plans for a restructuring of Water Quality subcommittee schedules and meeting format. This structure has been reviewed and approved by current subcommittee leadership and has also been presented to all other WQ subcommittees over the past 2 months.

Noting the need for member input during the 208 Plan overhaul process and an overlap in membership and topics, TMACOG staff proposed that two Planning Groups are formed to hold combined meetings of 5 subcommittees: Infrastructure Planning would combine Wastewater and Public Water Supply, and Watershed Planning would combine meetings of Watersheds, Agriculture, and Portage River Basin Council. Each subcommittee will retain a separate work program and leadership. Staff will work with chairs to plan meetings that allow members to provide feedback on 208 work, engage speakers for special topics, and offer continuing education credits.

She then gave an overview of the Annual Work Plan. It will be finalized at the January meeting. She discussed possible changes and rationale for them. TMACOG will send current AWP with track changes prior to the next meeting.

### Member Update:

City of Toledo – Michael Somerville – Toledo completed projects: filter & pipe gallery. Basin 1 & 4 upgrades, punch list by end of year. For 2024, high service pump station, lab improvements – 2 are complete, 3<sup>rd</sup> will be done in 2024, Pump station improvements, Collins Park roadway and site improvements. Lagoon bidding will happen in 2024. Toledo was awarded a \$2.5 million grant from H2Ohio for water mains.

Sylvania- Water line replacement along Rt. 20 area in advance of roadwork. Pump stations – on a cycle, looking at all for maintenance. Working with City of Toledo on master meter replacement.

Whitehouse- Grant for water tower, being planned with help from Kleinfelder, adding 500,000 gallon storage.

Perrysburg – Switching to AMI -75% coverage done, relocating Gateway to get to 90%. Replacing 4" water mains, 1 out for bid, 1 absorbed into design. Master meter replacement near the Trail. Major changes to ground storage, increase reservoir.

## **OEPA Update:**

Mike Deal – lead and copper rule proposal has been published in the Federal Registry. Initial revision utilized trigger rule at 10 - 20% increase for state on this. The comment period is 60 days beginning yesterday. Virtual public hearing Jan 16, 2024. 3 years from rule adoption to implement – 2027 date. Green construction loans deadline March 1, 2024., put you in running for funding available moving forward. Some 0% interest, always below market value if interest charged.
