Welcome:

Kevin Aller, Chair, City of Sylvania began the meeting with welcome. He asked everyone to introduce themselves.

Approval of February 1st Meeting Minutes:

Water Workforce Coalition Update:

Matt Kennedy, TMACOG, gave an update on the progress of the Water Workforce Collaborative including the name change. He stated that we are looking for mentors, internship opportunities, plants to tour and on the job training opportunities for the students. He is looking into the possibility of CEUs for those involved.

2023 208 Plan Update:

Matt Kennedy stated that he will be sending FPA update requests in the next couple of weeks. Overhaul will include FPA updates every 4 years instead of annually. Maps will be more interactive.

Member Update:

Sylvania is in Phase 3 of diameter lining project or replacement. They are using OWEA loans.

Whitehouse finished their force main replacement. They are now relining older sewers in older sections from the early 1960s.

City of Toledo improvements at wastewater plant are ongoing. Costs have risen and they will need to go to the voters for more money.

Lucas County has a 90" lining project in Monclova on Jerome Rd. They have advertised phase 4- \$8 million projected budget. They rejected all bids and are reevaluating the project amount was way more than expected. They are currently looking at UV system and digester system repairs.

OEPA Update:

Tiffany Kavalec Has a new position with policy and procedures. The Division Chief position is open.

There is a new person for the 208 plan. This person will have to update the state plan.

Maumee General Permit May 12 will start the preview period, Meeting June 1 to discuss comments from preview period.

Maumee TMDL goal to send final draft is the end of May. The OEPA is looking for feedback from other states with a general permit.
