## 2023 TRANSPORTATION ALTERNATIVES AND CARBON REDUCTION PROGRAM SCORING AND FUNDING RECOMMENDATION STAFF REPORT

## TOLEDO METROPOLITAN AREA COUNCIL OF GOVERNMENTS BOARD OF TRUSTEES MEETING AGENDA DECEMBER 13, 2023

The proposed scoring and ranking of the 2023 solicitation of Transportation Alternatives (TA) and Carbon Reduction Program (CRP) funding is now presented on the following spreadsheet to the Board of Trustees for consideration. TMACOG seeks approval to allocate approximatley \$1,400,000 of TA and \$2,000,000 of CRP funding through state fiscal year 2029 to project applications received in this round. This proposal will allocate a total of approximately \$3,400,000.

TMACOG received 9 applications from 9 entities requesting approximately \$6,800,000 of TA and CRP funding. The projects received were reviewed, scored, and ranked by a subcommittee of the Transportation Improvement Program (TIP) Committee and Pedestrian and Bikeways Committee. The scoring and ranking presented in this resolution has been approved by the TIP Committee and the Transportation Council.
