

Stormwater Coalition October 19, 2023 – 1:00 -2:30 p.m. TMACOG Boardroom Toledo, Ohio

Welcome

Jay Mosley Chair, Lucas County Engineer's Office, began the meeting with welcome. He asked for round table introductions. He then asked for the staff report.

Staff Report

Kari Gerwin, TMACOG, Financial statement – we are overspent – 125% of budget has been spent. Will be using TMACOG member dues to cover additional expenses. Largely due to extra staff time for unexpected program needs.

Eric Kostecky, TMACOG, update on CCCW – google analytics not showing data for recent months. Updated data will be coming once this is fixed. The material order will be confirmed next week and then the order will be placed.

Ohio EPA Update

Jay Mosley introduced Archie Lunsey, Chief Community Officer NWDO, Archie Lunsey gave a brief background of himself and his position with Ohio EPA and how it differs from Shannon Nabors' position. Director Vogle has changed the position to create consistency across the district offices in Ohio. Members will work with the same people and receive the same services, but it should be faster with redistributing workloads where needed. This position now includes outreach and will work proactively with the regulated community. OEPA is actively looking to replace people who they have lost in stormwater. Mr. Lunsey answered members' questions.

Action items tabled.

As there was not a quorum, Jay Mosley tabled action items. A special meeting will be called to vote on those items in the next few weeks. Kevin Aller asked if the special meeting could be held remotely. Kari Gerwin confirmed that a state bill would allow organizations like TMACOG to host virtual business meetings, but it has not yet passed.

Framework for SWC Mass Media Campaign

Eric Kostecky gave background on mass media campaign. He stated that there would be a virtual presentation on November 1 for the MMC. He discussed how this works into the AWP and what the benefits are for both MMC and CCCW and gave recommendations for moving forward. Followed by Q & A. There was much discussion of the value of CCCW and concern that members didn't want to get rid of CCCW due to its value for educational content and readymade materials. Members discussed the possibility of running both concurrently. No decision could be made as there was not a quorum.

SWC Ad Hoc Finance Committee Update

Jason Sisco, Wood County, gave background of why the ad hoc Finance Committee was formed. He gave an overview of the current plan for dues for 2024. This is still being worked on and not finalized.

SWC Current Work and Next Steps

Kari Gerwin discussed the AWP focus for the coming year. This will focus on critical work program development, program administration, and member identified priorities.
