2025 CONGESTION MITIGATION AND AIR QUALITY (CMAQ), TRANSPORTATION ALTERNATIVES (TA), AND CARBON REDUCTION PROGRAM (CRP) SCORING AND FUNDING RECOMMENDATION STAFF REPORT

TOLEDO METROPOLITAN AREA COUNCIL OF GOVERNMENTS MPO POLICY BOARD MEETING AGENDA SEPTEMBER 3, 2025

The proposed scoring and ranking of the 2025 solicitation of Congestion Mitigation and Air Quality (CMAQ), Transportation Alternatives (TA), and Carbon Reduction Program (CRP) funding is now presented to the MPO Policy Board for consideration. TMACOG's CMAQ solicitation identified \$15,788,000 in available funding and TMACOG's TA solicitation identified \$3,020,000 in available funding in fiscal years 2029-2031. In addition, TMACOG's CRP identified \$4,576,000 in available funding. This program will divide and apply funds equally between the CMAQ and TA programs. This proposal will allocate a total of approximately \$20,411,000 to 17 projects.

TMACOG received 13 applications from nine entities requesting approximately \$24,245,000 of CMAQ funding. TMACOG also received six applications from six entities requesting approximately \$3,151,000 of TA funding. The CRP does not have a separate application as those funds are divided and applied equally between the CMAQ and TA programs. The projects received were reviewed, scored, and ranked by a subcommittee of the Technical Advisory Committee (TAC). The scoring and ranking presented in this resolution was reviewed approved by the Technical Advisory Committee on August 20, 2025.

A RESOLUTION OF THE TOLEDO METROPOLITAN AREA COUNCIL OF GOVERNMENTS APPROVING THE CONGESTION MITIGATION AND AIR QUALITY (CMAQ), TRANSPORTATION ALTERNATIVES (TA), AND CARBON REDUCTION PROGRAM (CRP) SCORING AND FUNDING RECOMMENDATION

WHEREAS, the Toledo Metropolitan Area Council of Governments (TMACOG) is a voluntary association of local governments in northwest Ohio and southeast Michigan, organized on May 31, 1968, and established under Chapter 167 of the Ohio Revised Code and the Michigan Public Act No. 7 (EX-SESS), and has carried out comprehensive metropolitan and regional planning since that date; and

WHEREAS, the Toledo Metropolitan Area Council of Governments (TMACOG) is designated as the Metropolitan Planning Organization (MPO) by the Governor through the Ohio Department of Transportation in cooperation with local elected officials and is authorized to carry out the continuing, cooperative, and comprehensive transportation planning process (Process) for the Toledo area that results in plans and programs that consider all transportation modes and supports community development and social goals; and

WHEREAS, the MPO has been designated by the U.S. Department of Transportation and the Ohio Department of Transportation (ODOT) to direct, coordinate, and administer, the Process in the Toledo area as mandated by the Congress in Titles 23 and 49 U.S.C.; and

WHEREAS, the FY 2026-2029 Transportation Improvement Program (TIP) was approved by the TMACOG MPO Policy Board by Resolution Number 2025-06 on April 21, 2025, and

WHEREAS, it is necessary to approve the 2025 Congestion Mitigation and Air Quality (CMAQ), Transportation Alternatives (TA), and Carbon Reduction Program (CRP) Scoring And Funding Recommendation; and

WHEREAS, the addition of funds in this resolution was approved by the Technical Advisory Committee on August 20, 2025; and
