#### FY 2024-2027 TIP Amendment #1 - STAFF REPORT

## TOLEDO METROPOLITAN AREA COUNCIL OF GOVERNMENTS EXECUTIVE COMMITTEE MEETING AGENDA SWPTEMBER 20, 2023

Proposed Amendment #1 to the FY 2024-2027 Transportation Improvement Program is now presented to the Executive Committee for consideration.

- 1. Add four projects to the FY 2024-2027 TIP at the request of the project sponsors. The projects are:
  - a. City of Rossford WOO TR 110 5.4
    PID 116382 \$2,500,000 Federal STBG/Local FY 2026 CO
    This project does use TMACOG-managed funds. The amendment will add this project to the TIP. This project was previously programmed in the FY 2021-2024 TIP, but the project scope has changed to a roundabout.
    - b. ODOT LUC IR 475 10.21 3<sup>rd</sup> Lane Addition
      PID 115418 \$2,000,000 Federal/State FY2024 DD
      This project does not use TMACOG-managed funds. The amendment will add the preliminary engineering detailed design phase to the TIP. The construction funds have not been secured.
    - c. ODOT WOO Roche De Boeuf Interurban
       PID 107405 \$63,000 State FY 2024 RW
       This project does not use TMACOG-managed funds. The amendment will add the right-of-way phase to the TIP.
    - d. City of Rossford WOO CR 9 5.86 Lime City Widening PID 117233 \$186,526 – CMAQ/Local – FY 2024 – PE Environmental \$33,175 – CMAQ/Local – FY 2025 – DD

This project does use TMACOG-managed funds. The amendment adds the preliminary engineering environmental and detailed design phases to the TIP. The amendment will also remove the right-of-way phase from the TIP and use the CMAQ funds that were in right-of-way for the preliminary engineering environmental, the preliminary engineering detailed design phases of the project. The TIP Committee agreed to hold the balance of the remaining CMAQ from the right-of-way and use that balance in the construction phase in 2027, if necessary. The balance that could potentially be used for construction is \$586,639.

- 2. Remove one project phase from the FY 2024-2027 TIP at the request of the City of Rossford. The project is:
  - a. City of Rossford WOO CR 9 5.86 Lime City Widening
    PID 117233 \$762,400 CMAQ/Local FY 2026 RW
    This project does use TMACOG-managed funds. The amendment removes the rightof-way phase from the TIP and use the CMAQ funds for the preliminary engineering
    environmental, the preliminary engineering detailed design phases of the project. The

TIP Committee agreed to hold the balance of the remaining CMAQ from the right-ofway and use that balance in the construction phase in 2027, if necessary. The balance that could potentially be used for construction is \$586,639.

- 3. Modify one project in the FY2024-2027 TIP at the request of the City of Toledo. The project is:
  - a. City of Toledo LUC CR 500 2.61 MLK Multiuse Path PID 111533 \$10,245,000 CMAQ/CRP/Local FY 2024 CO This project does use TMACOG-managed funds. This project will increase the construction phase cost estimate from \$4,000,000 to \$10,245,000. This amendment will also increase the TMACOG-managed funds to \$4,237,615. The remaining \$6,007,385 will be shown as local match in the TIP.
