

**NOTES FROM THE TMACOG
SYSTEM PERFORMANCE & MONITORING COMMITTEE MEETING**

The meeting was held on January 6, 2020 at 1:30 p.m. in the TMACOG Boardroom, 300 Dr. Martin Luther King, Jr. Drive, Suite 300, Toledo OH 43604.

- I. Call to Order** – Chair of the System Performance and Monitoring committee, Andy Langenderfer, called the meeting to order. Attendees included Stephanie Bartlett, Pete Bick, Brooke Biniker, Jamie Blazeovich, Andy Langenderfer, Corrinne Lochtefeld, Babar Stelzer, Gary Stookey, Lisa Householder, and Marc VonDeylen.
- II. 2021 Annual Work Program** – The committee reviewed the contents within three sections of the Annual Work Program for the upcoming (2021) fiscal year. These sections included Safety Studies (60123), Continuing Planning – Data Collection and Management (60510), and Continuing Planning – Modeling and Forecasting (61520). The committee was asked to review the sections and provide any comments or new items by the end of February before the first draft is due to ODOT in early March. TMACOG staff proposed minimizing the Safety Locations Report (released every three years) by compiling the top regional crash list on an annual basis as well as producing more statistics for jurisdictions in the region. The committee was in support of this change.
- III. Regional Safety Plan – Draft Report** – The Transportation Safety Plan for the TMACOG region is complete. Lisa reviewed the various sections of the Plan and the committee discussed the implementation strategies moving forward.
- IV. Crash Diagram Review – McCord Road roundabout and grade separation** – The committee reviewed before and after crash data for the McCord Road roundabout and grade separation project in Holland, completed in 2016. In the two years after the project opened (2017 and 2018) crashes have increased but severity has lessened. It may be worth reviewing this location again in the future as area drivers adapt to the multi-lane roundabout and determine if crash numbers go any lower.
- V. Younger Driver Crashes** – TMACOG staff has been working on a member request for Toledo Children’s Hospital involving younger driver (15-20 years) crash data. Various statistics and an online interactive map for both Lucas and Wood counties from 2014-2018 were reviewed and discussed. Pete suggested including information on single-car versus multi-car crashes involving these younger drivers.
- VI. Asset Management Plan** – This discussion topic was mentioned briefly when staff reviewed the Annual Work Program agenda item. The committee will discuss this topic in greater detail at the March meeting.
- VII. Other Business** – Lisa mentioned TMACOG has several events coming up, including:
 - Every five years TMACOG is required to undergo a certification review with FHWA and FTA. This will take place on January 14 and 15 at TMACOG. A public meeting will take place on the 14th from 5:00 to 7:00 p.m. in the Grand Lobby outside the office.
 - The TMACOG General Assembly will be held on January 27 at the Hilton Garden Inn, Perrysburg starting at 8:00 a.m. Registration for that event is now open.
 - TMACOG staff will be holding various public meetings for the 2045 Long Range Plan Update in February. Lisa will attach those dates and times when meeting minutes are emailed to committee members.
 - The Transportation Summit will take place on March 27 at the Premier Banquet Hall, Toledo. Registration will open soon for that event.
