



# 2025 Summer General Assembly

## Business Meeting Notes

### Wednesday, August 8, 2025

**Welcome/Call to Order/Pledge of Allegiance** – The annual Summer General Assembly business meeting was held on Wednesday, August 8, 2025, at 10:30 a.m. in the Veterans Hall Auditorium at the Owens Community College Toledo area campus in Perrysburg, Ohio. TMACOG Chair Ed Schimmel called the meeting to order. The meeting opened with the Pledge of Allegiance. A quorum was not present to conduct business.

**Chair's Remarks** – TMACOG Chair Schimmel welcomed everyone in attendance. Owens Community College was thanked for offering their facilities for the event. Owens prepared giveaway bags for all attendees. Penta is where the program is typically held. However, this summer the school has an ongoing expansion project. Penta was congratulated on their project.

**Executive Director's Report** – TMACOG Executive Director Sandy Spang recognized and thanked the event supporters and partners and asked to stand to be recognized. Several of them placed giveaway items on the meeting tables or had posters on display at the event. State and federal officials in attendance were recognized for their attendance.

Mrs. Spang reported on the Moving Forward 2055 Long-Range Plan that was recently approved by the MPO Policy Board. She also gave an update on the outcome of the Ohio Conference on Freight that was hosted by TMACOG July 29-31 at the Glass City Center. TMACOG is also hosting Pathways to Public Service on October 9 from 4:30-7:30 p.m. in Heritage Hall Room 123 at Owens Community College.

Marissa Bechstein, the program manager for TMACOG new Economic Development Department was introduced and recognized, as well as Annsley Mann and Sean Sammon, who are new on staff at TMACOG. Miss Mann is a grants and policy specialist in the Economic Development Department, and Mr. Sammon is a program manager in the Transportation department. Finally, Mrs. Spang announced that TMACOG now has a new phone system. The main line remains the same; however, staff extensions have been replaced with direct dial phone numbers.
